ORDINANCE NO. 24-1039

AN ORDINANCE AMENDING TITLE 13, SECTION 13-1-58, SECTION 13-1-105(J), SECTION 13-1-129(B), AND SECTION 13-1-151(E) OF THE CODE OF ORDINANCES OF THE CITY OF VERONA

The Common Council of the City of Verona, Dane County, Wisconsin, does ordain that Sections of the Code of Ordinances of the City of Verona are amended to read as follows (language added/language deleted):

- 1. Section 1-1-58 Definitions P.
 - (m) Personal Vehicle Storage Facility (Land Use). Land uses oriented to the indoor storage of vehicles, recreation vehicles, boats, all-terrain vehicles, and similar types entirely within partitioned buildings having an individual access to each partitioned area. Such storage area may be available on either a condominium or rental basis; and may include clubhouse like facilities for use of its members and guests. This definition does not include the storage of vehicles for commercial use.
- 2. Section 13-1-105 Use Matrix.

- 3. Section 13-1-129 Specific Vehicle Related Use Standards.
 - (b) Personal Vehicle Storage Facility.
 - (1) A personal vehicle storage facility may contain an incidental clubhouse, gathering building, or patio that cannot be leased or rented to any person, group, or entity for a function that is outside of the owners or users of the facility.
 - (2) The storing of hazardous or toxic material is prohibited.
 - (3) No storage space shall be used for residential occupancy, or the storage of commercial or industrial inventory or raw materials.
 - (4) The storage of vehicles associated with a business shall be incidental to the storage of personal property. There shall be no exterior evidence of business operations. No employees of a business or customers of a business shall be present other than the owner/renter of the space themselves.

- (5) Exterior building materials shall be time- and weather-tested materials and techniques such as but not limited to masonry, stone veneer systems, stucco, precast panels with inlaid or stamped brick texture.
- (6) Multiple buildings are permitted with extensive landscaping between the buildings to include canopy trees.
- (7) Washing of vehicles outside of buildings is prohibited.
- (8) Sink and toilets are allowed in each unit.
- (9) Showers are prohibited except in the clubhouse or gathering building.
- 4. Section 13-1-151 Off-Street Parking and Traffic Circulation Standards.
